#### HOW TO APPLY FOR A PRICE CITY BEER LICENSE

To serve beer in your place of business, you must obtain a license from Price City and the State of Utah, Department of Alcoholic Beverage Control (UDABC). The UDABC will require a signed local consent, or license to sell beer, from the City and a copy of your Business License Certificate. You may contact the UDABC at 1625 South 900 West, Salt Lake City, Utah, or phone (801) 977-6800 to receive the state packet and more information. *If you are applying for a Temporary Special Beer Permit, you do not need to obtain a separate license from the State*.

# PRICE CITY BEER LICENSE CLASSIFICATIONS

Class "A" Beer sold on draft or in the original bottles or cans for consumption on or off the premises. Class "B" Packaged beer sold in a grocery store or a retail store that maintains a grocery department for consumption off the premises. Class "C" Beer sold by a restaurant for consumption on the premises in original containers not to exceed one (1) quart. Sale of food must constitute at least 80% of the gross money receipts. Class "D" Beer in original unopened bottles or cans delivered with food or groceries to persons within Price City or political subdivisions outside the corporate limits of Price City which have adopted an ordinance permitting the home delivery of beer. CHECKLIST FOR REGULAR LICENSE Complete the Beer License Application. Return completed application to the Business License Administrator (City Treasurer) located at City Hall, 185 East Main. Pay the annual fee of \$300 at the Price City Utilities Department at City Hall, 185 East Main. Your request will be added to the next City Council Agenda for approval. Council meetings are held the second and fourth Wednesdays of each month. A Beer License will be mailed to you when approvals have been received from the Business License Administrator, Police Department, and City Council.
